Dear Administrator Tavenner,

As you will recall, in March 2013, a bipartisan group of 31 Members of the House of Representatives contacted you to raise concerns about preferred pharmacy networks and to urge CMS to expand the opportunities for all pharmacies to join and compete with these Part D preferred networks on a level playing field. We wish to express our appreciation regarding the proposed changes to the use of preferred pharmacy networks in the Medicare Part D program.

We strongly support efforts to make prescription drugs more affordable and preserve beneficiary access. For this reason, we are encouraged that the proposed rule addresses the problem we highlighted by calling for Medicare Part D plans to include any willing pharmacy to participate in their preferred pharmacy network, which will ensure seniors receive comparable costs to fill prescriptions at their local pharmacies.

As you know, some seniors, especially in rural areas, reported having to travel upwards of 20 miles in order to get their medications from a preferred pharmacy network because their local community pharmacy was not given the opportunity to participate in such a network. The proposed changes to preferred pharmacy networks will protect vital small businesses and jobs while most importantly strengthening Medicare beneficiaries' access to quality care.

While those of us signing this letter may have differing opinions regarding other provisions of the rule, we thank you for listening to our views and applaud the proposed rule's provisions concerning preferred pharmacy networks. Thank you for working with us on this crucial access to health care issue.
